## 26th ANNUAL 50+ MIXED TOURNAMENT RULES

1. Tournament is certified by USBC and open to all current adult members of the Denton County USBC who are 50 years of age or over as of date of tournament competition. \*\*\* If certified in another Association, participants must pay Denton Local Association Dues of \$10.00

**Tournament dates: January 16, 17, 18, 2026** Entry closing date: Thursday, January 8, 2026 Entries can be turned in to Tom Turner (Association Manager) or any member of the Denton County USBC Board on or before January 8, 2026, or can be postmarked no later than January 9, 2026.

LATE ENTRIES WILL BE ACCEPTED WITH A \$10 PER PERSON LATE FEE UNTIL 10PM ON JANUARY 15th 100% of any late fees collected will be added to the prize fund.

- 2. **Handicap:** Team (2 men & 2 women) (90% from 920) Doubles (1 man & 1 woman) (90% from 460) Singles (90% from 230)
- 3. **MULTIPLE ENTRIES**: An entrant may:
  - a. Bowl and cash more than once in the **DOUBLES** EVENT. Doubles will be a virtual event that is collected onsite.
  - b. Only enter **SINGLES** once.
  - c. Bowl more than once in the **TEAM** EVENT. Two bowlers on the team must be different to cash more than once.
  - d. Highest team series will count for All Events score.
- 4. Entering average (IN PRIORITY LISTED):
  - a. DCUSBC 2024-2025 high book average (Fall).
  - b. Bowl.com 2024-2025 high average of 21 games or more (Fall or Summer)
  - c. Highest current average of 21 games or more as of January 1, 2026.
  - d. If the above rules do not apply, bowler will bowl with a scratch average of 230.

BOWLERS ARE RESPONSIBLE FOR VERIFYING THEIR OWN AVERAGES WHETHER SUBMITTED BY THE BOWLER, TEAM CAPTAIN OR OTHERS (SEE RULE 319A-3). INCORRECT AVERAGES ARE SUBJECT TO DISQUALIFICATION. USBC Rule 319c does apply: Average Adjustments (Re-rating). Rule 319a (2), 319d and 319e are waived.

- 5. Prize money to be paid 100%; Prize ratio (approximate): 1 in 7 for Team,1 in 7 for Doubles,1 in 7 for Singles, and 1 in 11 for All Events. Singles and All Events will have two (2) divisions, men and women. \$1500 will be added to the prize fund. \$500 for Team, \$500 for Doubles, \$250 for Men's Singles and \$250 for Women's Singles. Trophies/awards will be given for the first place only in Team, Doubles, and Singles. (Not All Events) Co-champions will be declared when there is a tie for championship (first place) of any event and duplicate awards will be presented. Prize money will be distributed within 30 days after close of tournament. TEAM CAPTAINS MUST DISTRIBUTE WITHIN 30 DAYS FROM RECEIPT. High Scratch All Events (6 games Team and Singles) (one male and one female) will receive an entry to the state Senior Queens and Senior Masters tournament. Entry will be reimbursed after participation. This can be used in 2026 or 2027. Tie will be broken by a 3 game scratch series to be bowled at a later date arranged with the association manager.
- 6. No entry forms will be accepted without entry fee attached. Fees to be paid by personal check, cashier's check, money order, sponsor's check or Zelle **CASH WILL NOT BE ACCEPTED**. Return check fee: \$25.00
- 7. Substitutions should be reported to the Association Manager as soon as possible, preferably one hour before squad time. Substitute will take the position of the replaced bowler.
- 8. Lanes will be scheduled by the tournament committee and will not be changed except for an emergency.
- 9. PRACTICE: 10 minutes Bowlers will throw one ball and move to the end of the line. Pins will not be reset.
- 10. Any player or team arriving after the game has started will be allowed to bowl and the score will count in the frame then being bowled. ZERO SCORE WILL BE GIVEN FOR FRAMES MISSED.
- 11. All bowlers should check in 30 minutes before squad time. Membership cards must be presented at check in time by all participants unless membership has already been verified by Association Manager.
- 12. NO CHILDREN WILL BE ALLOWED IN BOWLING AREA DURING COMPETITION.
- 13. NO UNAUTHORIZED BRACKETS ALLOWED. **Denton County USBC will provide brackets**.
- 14. Members are requested to consider suitable attire when participating in this tournament.
- 15. No smoking will be allowed in the bowling center during the tournament.
- 16. USBC Tournament Rules shall govern this tournament in addition to the rules adopted by the Denton County USBC Tournament Rules Committee which will decide any questions not covered by these Tournament Rules.

The entrants whose names appear hereon or their authorized replacements hereby agree that the Denton County USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when those entrants shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto or resulting there from fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Denton County USBC, Inc.
