65th ANNUAL DENTON WOMEN'S TOURNAMENT RULES

1. Tournament is certified by USBC Nationals and open to all current women adult members of the Denton County USBC..
Tournament dates: February 5 - 6, 2022 ** Entry closing date: Thursday, January 27, 2022
Entries can be turned in to Tom Turner (Association Manager) or any member of the Denton County USBC Board on or before **January 27, 2022**, or can be postmarked no later than January 28, **2022**.
LATE ENTRIES WILL BE ACCEPTED WITH A \$40 LATE FEE PER ENTRY FORM RECEIVED.
Walk-In Entries will be accepted with a \$40 late fee until 30 Minutes prior to squad time selected.
2. **Handicap: Team (90% from 920) Doubles (90% from 460) Singles (90% from 230)**
3. **MULTIPLE ENTRIES:** AN ENTRANT MAY PARTICIPATE MORE THAN ONCE IN EACH EVENT; HOWEVER, to cash in multiple events, 2 members per team must be different. You may only cash once with the same Doubles partner and you may only cash once in Singles. Your highest series in each event will count towards optional All Events.
4. **Entering average (IN PRIORITY LISTED):**
 - A. Highest 2020 - 2021 Denton County book average
 - B. Highest 2020 - 2021 average from Bowl.com
 - C. Current average of at least 21 games as of January 20, 2022.
 - D. If none of the above rules apply, entrant will bowl with a scratch average of 230.

*** If certified in another Association, participants must pay Denton Local Association Dues of \$10.00

BOWLERS ARE RESPONSIBLE FOR VERIFYING THEIR OWN AVERAGES WHETHER SUBMITTED BY THE BOWLER, TEAM CAPTAIN OR OTHERS (SEE RULE 319A-3). INCORRECT AVERAGES ARE SUBJECT TO DISQUALIFICATION. USBC Rule 319a (2), 319d and 319e are waived.

USBC Rule 319c does apply: Average Adjustments (Re-rating).
5. No entry forms will be accepted without entry fee attached. Fees to be paid by personal check, cashier's check, money order sponsor's check or Zelle- **CASH WILL NOT BE ACCEPTED.** Return check fee: \$25.00
6. Substitutes will take the position of the replaced bowler and no rearranging of the lineup will be made. Substitutions should be reported to the Association Manager as soon as possible, preferably one hour before squad time.
7. Lanes will be scheduled by the tournament committee and will not be changed except for an emergency.
8. PRACTICE: 10 minutes
9. Any player or team arriving after the game has started will be allowed to bowl and the score will count in the frame then being bowled. ZERO SCORE WILL BE GIVEN FOR FRAMES MISSED.
10. All bowlers should check in 30 minutes before squad time. Membership cards must be presented at check in time by all participants unless membership has already been verified by Association Manager.
11. Prize money to be paid 100%. Prize ratio (approximate): 1 in 5 entries in Team, Doubles and Singles. 1 in 11 entries in All Events. Trophies/awards will be given (in addition to prize money) for first place only in Team, Doubles, and Singles. (Not in All Events.) Co-champions will be declared when there is a tie for championship (first place) of any event and duplicate awards will be presented. Prize money will be distributed within 30 days after close of tournament. TEAM CAPTAINS MUST DISTRIBUTE WITHIN 30 DAYS FROM RECEIPT.
12. NO CHILDREN WILL BE ALLOWED IN BOWLING AREA DURING COMPETITION.
13. NO UNAUTHORIZED BRACKETS ALLOWED. **Denton County USBC will provide brackets.**
14. Members are requested to consider suitable attire when participating in this tournament.
15. USBC Tournament Rules shall govern this tournament in addition to the rules adopted by the Denton County USBC Tournament Rules Committee which will decide any questions not covered by these Tournament Rules.

The entrants whose names appear hereon or their authorized replacements hereby agree that the Denton County USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when those entrants shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto or resulting there from fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Denton County USBC, Inc.
