NUTTY 500 CLUB

1. **Tournament Date:** **08-10-24 (Saturday), 1:00 pm**, at Bowlero/Denton and is open to all members of the Nutty 500 Club who are paid members in good standing as of 07-30-24. Bowler will bowl 4 games and throw out lowest game. Winners to be determined by 3-game handicap series.
 2. **ENTRY CLOSING DATE:** **Tuesday, 07-30-24.** **ENTRY FEE: \$ 30.00** Entry form may be turned in to any Nutty 500 Board Member by 07-30-24 or postmarked no later than 07-31-24.
 3. **Average** to be used for this tournament shall be (**in priority listed below**):
 - B - Highest **2022-23** Denton County USBC Book Average.
 - F - Highest **2023-24** Final Fall Denton County USBC Average of 21 games or more.
 - S - Highest **2024** Summer Denton County USBC Average of 12 games or more as of **07-23-24**.
- **Bowlers are responsible for providing verification of their own averages from DCUSBC Leagues****
This will be a same-day cash payoff -- no bowler will be allowed to bowl without a verified average.
4. Handicap for this tournament will be 90% of the difference between entering average and 220.
 5. Any bowler arriving late or leaving early will receive zero for all frames missed.
 6. You will be allowed two practice balls on each of your bowling lanes.
 7. Prize fund will be returned 100%, at least one place for every four entries. In case of a tie for any position, place money for all tied positions will be combined and divided equally.
 8. Tournament scores may not be re-bowled, except as authorized by the Nutty 500 Executive Board when scores are irretrievably lost due to malfunction of an automatic scoring device.
 9. This will be a USBC certified tournament. USBC tournament rules and regulations shall govern tournament in addition to the rules adopted by the Board. Any questions or disputes will be referred to the Nutty 500 Board.
 10. Bowlers must have current Denton County USBC Membership Card or stub signed by a League Secretary.
 11. Members need not report previous tournament prize winnings.
 12. Substitutes will be allowed, if eligible, but no refunds after entry closing date.
