# NUTTY 500 CLUB

1. **This is a certified tournament** open to all members of the Nutty 500 Club who are paid members in good standing as of tournament entry closing date: **10-08-2024**. Entry Fee: \$25.00 (Make check payable to Nutty 500 Club)
2. **Tournament date: 10-19-24 (Saturday, 1:15 p.m.). Tournament entry closing date: 10-09-24.**  
Entry form may be turned in to any Nutty 500 Board Member by 10-09-24 or postmarked no later than 10-10-24.
3. Averages to be used for this tournament shall be (in priority listed):  
B - HIGHEST **2023-24** Denton County USBC Yearbook Average.  
C - If **NO** 2023-24 Denton County Yearbook Average, use highest Denton County USBC certified league average (in priority listed): (1) Summer 2024 (21 games or more) (2) Fall 2024-2025 – 12 games or more as of 10-08-2024  
**Bowlers are responsible for providing verification of their own averages from Denton County USBC Leagues.**  
b. Any members **not** meeting the above criteria may not bowl.
4. The following USBC Tournament Rule **DOES** apply to this tournament:  
**Rule 319a-3:** “Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captain or others. If the submitted average is lower than required and results in a lower classification or more handicap, the bowler’s score is disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average.”
5. The following Tournament Rules will be **WAIVED** for this tournament:  
**USBC Rule 319a-2:** (Average increase of 10 or more pins from prior season)  
**USBC Rule 319d:** (Reporting prior prize winnings)  
**USBC Rule 319e:** (Average adjustment for previous tournaments)
6. Handicap for this tournament will be **90%** of the difference between entering average and 220.
7. Any bowler arriving late or leaving early will receive zero for all frames missed.
8. You will be allowed two practice balls on each of your bowling lanes.
9. Prize fund will be returned 100%, at least one (1) place for every four (4) entries. In case of a tie for any position, place money for all tied positions will be combined and divided equally.
10. Tournament scores may not be re-bowled, except as authorized by the Nutty 500 Executive Board when scores are irretrievably lost due to malfunction of an automatic scoring device.
11. Any questions or disputes will be referred to the Nutty 500 Executive Board.
12. Bowlers must have current Denton County USBC Membership Card (or stub signed by a League Secretary).
13. Substitutes will be allowed, if eligible, but no refunds after entry closing date. No substitutions can be made in a singles tournament after series has started (USBC Tournament Rule 324b).
