# NUTTY 500 CLUB

- 1. Tournament date: 03-02-24 (Saturday, 1:00 p.m.). Tournament entry closing date: 02-20-2024. Entry form may be turned in to any Nutty 500 Board Member by 02-20-24 or postmarked no later than 02-21-2024.
- 2. Tournament is open to all Nutty 500 Club members who have paid 2024 membership dues on or before tournament entry closing date (02-20-24) and have a qualifying average (see Rule 3).
- 3. Averages to be used for this tournament shall be (in priority listed below):
  - B Highest 2022-23 Denton County USBC Book Average.
  - C Highest 2023-24 Denton County USBC Current Fall Average of 21 games or more as of 02-13-24.
  - S Highest 2023 Denton County Summer average of 21 games or more.

Any members not meeting the above criteria may not bowl.

\*\*Bowlers are responsible for providing verification of their own averages from Denton County Leagues\*\* This will be a same-day cash payoff -- no bowler will be allowed to bowl without a verified average.

- 4. Handicap for this tournament will be 90% of the difference between entering average and 220.
- 5. Any bowler arriving late or leaving early will receive zero for all frames missed.
- 6. You will be allowed two practice balls on each of your bowling lanes.
- 7. Prize fund will be returned 100%, at least one place for every four (4) entries. In case of a tie for any position, place money for all tied positions will be combined and divided equally.
- 8. Tournament scores may not be re-bowled, except as authorized by the Nutty 500 Executive Board when scores are irretrievably lost due to malfunction of an automatic scoring device.
- 9. This will be a USBC certified tournament. USBC tournament rules and regulations shall govern tournament in addition to the rules adopted by the Board. Any questions or disputes will be referred to the Nutty 500 Board.
- 10. Bowlers must have current Denton County USBC Membership Card or stub signed by a League Secretary.
- 11. Members need not report previous tournament prize winnings.
- 12. Substitutes will be allowed, if eligible, but no refunds after entry closing date.
